What is the purpose of this update?

This document tells you how the Conservative Trust has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Conservative Trust aims to provide stable returns over the short to medium term. The fund invests primarily in income assets but also has an allocation to growth assets. Volatility is expected to be higher than the Income Strategies Trust but lower than the Moderate Trust in the Westpac Active Series.

What are the risks of investing?

Risk indicator for the Conservative Trust.¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Small differences in fees and charges can have a big impact on your investment over the long term.

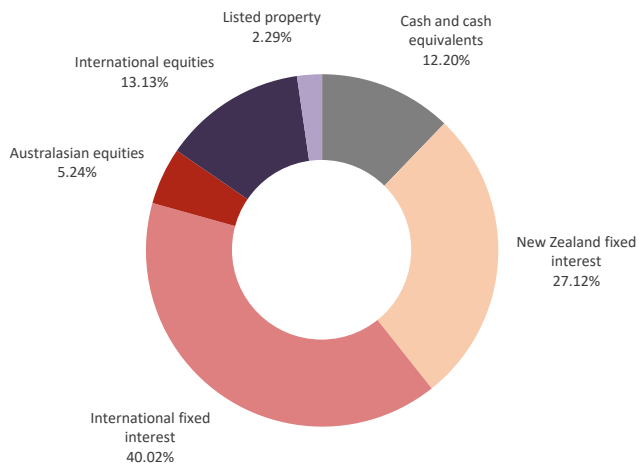
Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$576 (that is 5.76% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$576 for the year.

The top 10 investments make up 10.32% of the net asset value of the fund.⁶

Currency Hedging

Some of the asset classes in the fund have exposure to foreign currencies. As at 31 December 2024, the actual currency hedging is as follows:

- International fixed interest – 99% hedged (benchmark 100%)
- Australasian equities – 70% hedged (benchmark 70%)
- International equities – 54% hedged (benchmark 60%)
- Listed property (Australasian) – 99% hedged (benchmark 100%)
- Listed property (International) – 138% hedged (benchmark 139%)

Notes

1. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years.
