This fund update was first made publicly available on 30 April 2024.

#### What is the purpose of this update?

This document tells you how the Income Strategies Trust has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Income Strategies Trust aims to provide stable returns over the short to medium term. The fund invests in a diversified range of income assets. Volatility is expected to be the lowest of the funds in the Westpac Active Series. The fund closed to new investment on 18 April 2019.

#### What are the risks of investing?

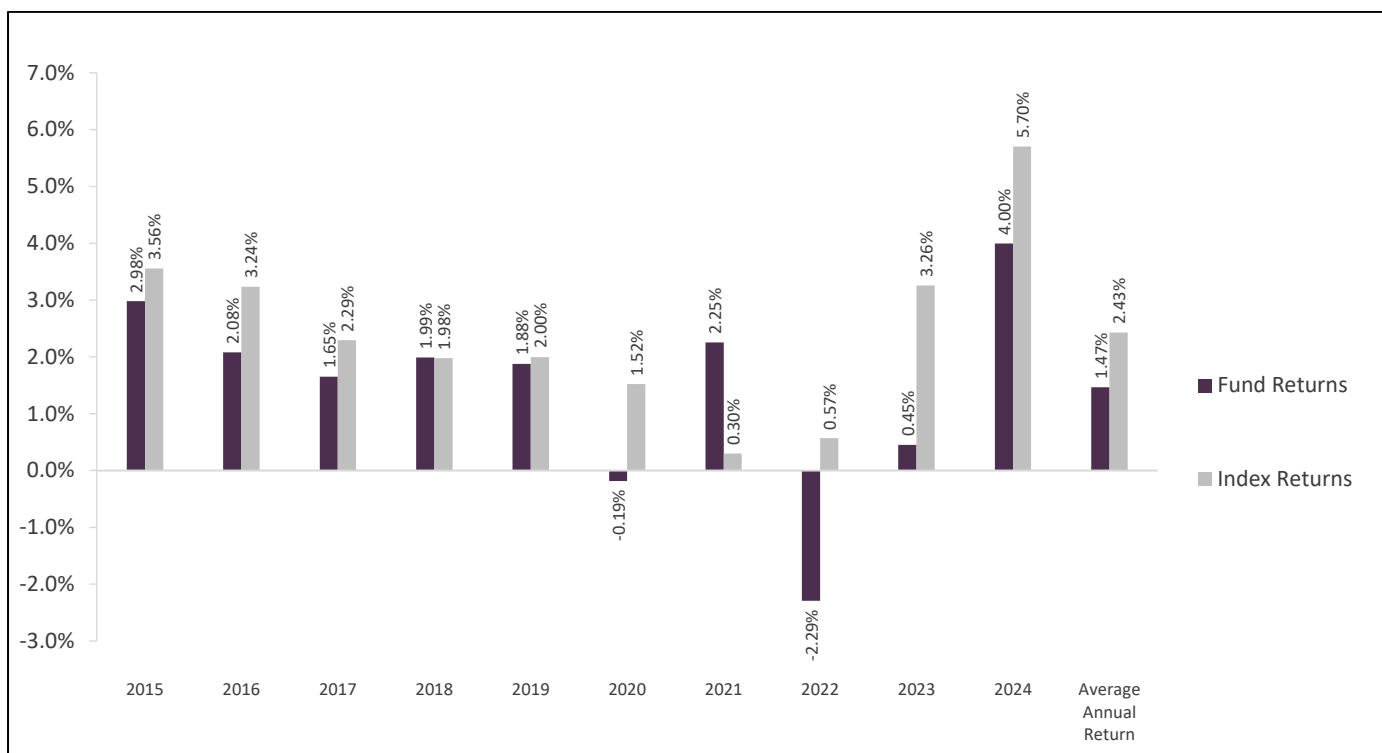
#### How has the fund performed?

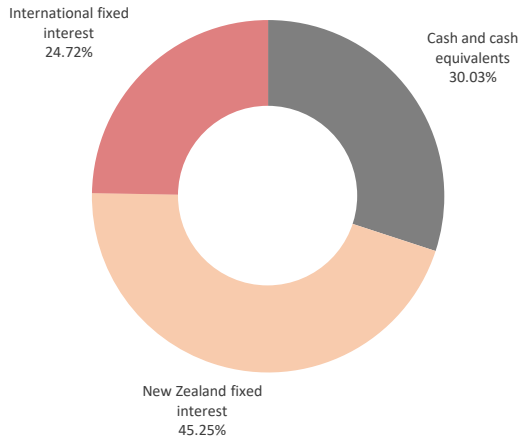
## Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$400 (that is 4.00% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$400 for the year.

## Currency Hedging

The international fixed interest asset class in the fund has exposure to foreign currencies. As at 31 March 2024, the actual currency hedging for the international fixed interest asset class was 99% (benchmark 100%).

## Notes

1. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle.
