What is the purpose of this update?

This document tells you how the Australasian Diversified Share Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Australasian Diversified Share Fund aims to provide capital growth over the long term by investing primarily in a diversified portfolio of listed New Zealand and Australian equities.

What are the risks of investing?

Risk indicator for the Australasian Diversified Share Fund.¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$1,634 (that is 16.34% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$1,634 for the year.

Notes

- 1. The risk indicator for the fund is calculated based on the volatility of past returns over five years, which is not a full investment cycle. In some cases the output may be different if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on was one of unusually low or unusually high volatility the risk category presented in a PDS (or any fund update) may provide a less reliable indication of the potential future volatility of a fund.

- 3. The top 10 investments have been calculated excluding cash and cash equivalents held for operational and hedging purposes.
