What is the purpose of this update?

This document tells you how the International Diversified Share Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The International Diversified Share Fund aims to provide capital growth over the long term by investing primarily in a diversified portfolio of listed international equities. The primary areas of investment are North America, United Kingdom, Europe and the Asia-Pacific region (and may include emerging markets).

What are the risks of investing?

Risk indicator for the International Diversified Share Fund.¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



The market index return reflects the benchmark index returns for the relevant period. Effective from 1 June 2017 the benchmark index for this fund was changed to the MSCI All Country World ex-Australia Net Index (69% hedged on a before tax basis to NZD) following a review of the investment strategy for the Fund. Prior to this date the MSCI World Index with Net Dividends reinvested measured in NZD (50% hedged on a before tax basis to NZD) was used.


Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$1,950 (that is 19.50% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$1,950 for the year.

Notes

- 1. The risk category for the fund is calculated based on the volatility of past returns over five years and this does not represent a full investment cycle.
