What is the purpose of this update?

This document tells you how the Accumulation Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Accumulation Portfolio aims to provide stable returns over the short to medium term. The Accumulation Portfolio invests in cash and a diversified range of income assets. Volatility is expected to be the lowest of the Portfolios in the Westpac Retirement Plan.

What are the risks of investing?

Risk indicator for the Accumulation Portfolio.¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

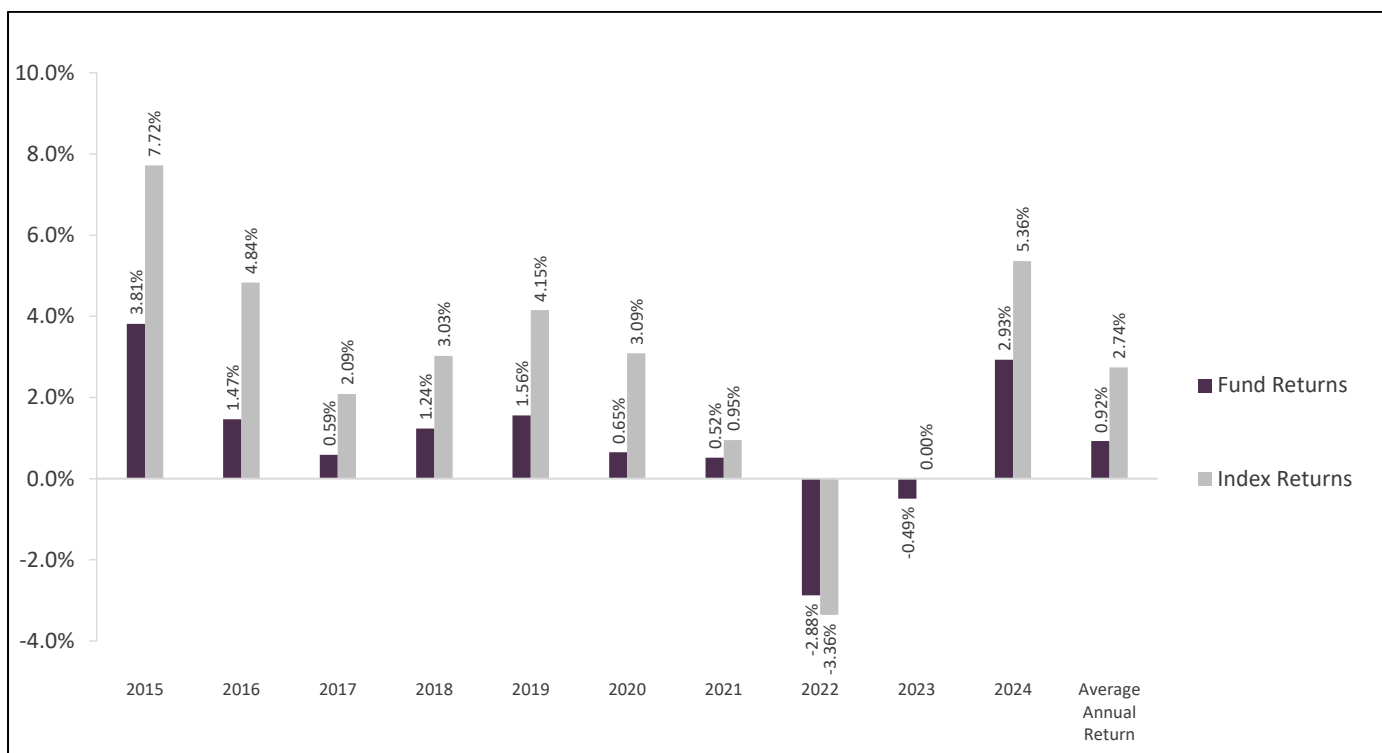

The market index return reflects a composite of benchmark index returns, weighted for the fund's target asset allocation. The benchmark indices used for each asset class are defined in the Statement of Investment Policy and Objectives (SIPO).

Effective from 1 November 2023, there has been a change to the benchmark for international fixed interest, which is an asset class within the market index. This change provides additional diversification to the benchmark and reflects changes made to the asset class strategy.

Annual return graph



This shows the return after fund charges and tax for each of the last 10 complete years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2024.

Small differences in fees and charges can have a big impact on your investment over the long term.

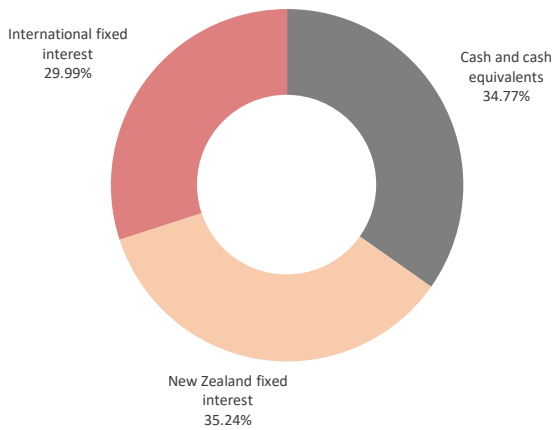
Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$293 (that is 2.93% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$293 for the year.

The top 10 investments make up 8.66% of the net asset value of the fund.⁵

Currency Hedging

The international fixed interest asset class in the fund has exposure to foreign currencies. As at 31 March 2024, the actual currency hedging for the international fixed interest asset class was 99% (benchmark 100%).

Notes

1. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on has had unusually low or high volatility the risk indicator presented in a fund update may provide a less reliable indication of a fund's potential future volatility.
