# Fund Update for the quarter ended:

This fund update was first made publicly available on 1 May 2020.

#### What is the purpose of this update?

This document tells you how the Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited<sup>1</sup> prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The Cash Fund aims to provide stable returns over the short term. The fund invests in income assets of a short term nature such as bank deposits, floating rate notes and money market securities. Volatility is expected to be the lowest of the funds in the Westpac KiwiSaver Scheme.

#### What are the risks of investing?

Risk indicator for the Cash Fund.<sup>2</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


### How has the fund performed?

This shows the return after fund charges and tax for each of the last 10 complete years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2020.

<sup>\*</sup>Following a decrease in the management fee and the other management and administration charges, the Manager estimates that the total fund charges for the next scheme year will reduce to 0.36% of the fund's net asset value.

Small differences in fees and charges can have a big impact on your investment over the long term.

#### Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$119 (that is 1.19% of his initial \$10,000). Jason also paid \$27 in other charges. This gives Jason a total return after tax of \$92 for the year.



#### **Notes**

- BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver Scheme
- 2. The risk indicator for the fund is calculated based on the volatility of past returns over five years, which is not a full investment cycle. In some cases the output may be different if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years.
